## TENDER NOTICE FOR CELLULAR PHONES SERVICE COMPANIES

Lahore Transport Company is a non-profit organization, wholly owned by Government of the Punjab and registered under Companies Ordinance, 1984. The Company is responsible for planning, managing, enforcing and regulating all types of public transport in the city of Lahore.

Lahore Transport Company invites sealed bids under Single Stage two envelope procedure as laid down under rule 38 of the Punjab Procurement Rules, 2014 for the Cellular Phones Service Companies.

Bids are invited from Cellular Phone Service Companies that meet and provide the proof of the following criteria:

- Sealed tenders are invited from cellular telecom services providers, having license from PTA (Pakistan Telecommunication Authority) in Pakistan, registered with Income Tax and sales tax departments for the purchase of 200 Sims for Lahore Transport Company.
- Tender documents and detailed specifications may be collected from the LTC Office on written request or may be downloaded from LTC website([www.ltc.gop.pk](http://www.ltc.gop.pk)). Tender fee Rs.1,000/- (non-refundable) in shape of Pay Order/Demand Draft in favor of Lahore Transport Company along with sealed bid duly filled according to the bidding documents and submit on or before 04/03/2015 at 11.00 A.M. to the Procurement Department of Lahore Transport Company, 4<sup>th</sup> floor, IEP Building, 97-B-D/1, Liberty Roundabout, Gulberg-III, Lahore which will be opened on the same date at 11.30 A.M. in the presence of bidder or their representatives who choose to attend the proceedings. Without tender fee bids will not be entertained. Other terms and procedure of bidders are mentioned on the bidding documents.
- The Bid Security @ (2%) of the bid amount in the form of Demand Draft/Pay order favoring Lahore Transport Company must be provided with the Bid, failing which the bid will be considered as non-responsive and shall be rejected.
- LTC may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
