## Tender Notice for Provision of Uniforms

Lahore Transport Company invites Tenders from Prequalified vendors of LTC for provision of uniform items for the Traffic Enforcement Inspectors (TEIs). The specifications are reflected in Tender document available on payment of Rs 500/- (Non Refundable) in the form of demand draft/pay order favoring Lahore Transport Company, from the office of LTC during working hours from **11:00 AM to 4:00 PM**. The Tenders will be deposited in sealed envelopes in tender box placed at reception of the office **by 11:00 AM** within 15 days from the date of issuance of this advertisement. It will be opened in the presence of bidders or their authorized representatives at **11:30 AM** on the same day.

### Terms and Conditions

- (i) Sealed bids along with Rs 1,000/- in the form of demand draft/Pay Order as bid money favoring LTC should reach Deputy Manager Admin Lahore Transport Company, 4<sup>th</sup> Floor, 97-B-D-/1, Liberty Roundabout, Engineering Center, Gulberg-III, Lahore on or **before 01 Oct 2011 by 11:30 hours which will be opened on the same day at 11:00 hours** in the presence of the prequalified bidders/authorized representatives.
- (ii) The successful bidder will provide performance security @ 1% of the total estimate of Tender in the form of Pay Order/ Demand Draft favoring Lahore Transport Company within two days of issuance of intimation letter, failing which the tender will not be considered. The earnest money will be returned to the unsuccessful bidders within seven days after the date of opening.
- (iii) The successful bidder will be bound to supply the required items on negotiated/agreed rates as per the requirements lasting **March 2012**. In case of disagreement or failure to supply the required items at any stage/period of the contract, the order will be cancelled and earnest money will be forfeited. Thereafter the order will be allotted to the next lowest bidder. The Earnest money will be kept for one month after the completion of delivered items as per the specifications of LTC.
- (iv) The pattern of uniform and required items can be inspected at the office during office hours before the closing date of the tender. The delivery of uniforms must start within 7 days after issue of work order/PO.
- (v) Only Premium quality cloth will be used for the uniforms.
- (vii) LTC reserves the right to accept or reject any or all bids and terminate the contract at any stage without assigning any reason what so ever.
